Are you a Veteran with service-connected disabilities traveling or living outside of the United States? You may be eligible for hospital care and medical services in foreign countries.


Additionally, VA may authorize necessary foreign medical services for Veterans participating in the VA Veteran Readiness and Employment Program.

Benefits of FMP

- A life-long benefit.
- No pre-authorization needed.
- See your choice of provider.
- Medical care covered for service-connected disabilities, or aggravating condition.
- Get reimbursed for prescription medications (must be FDA approved).
- Billing can be handled by your provider and VA.
- Register and file a claim at the same time.
- VA will translate documents for you after you submit a claim.

Eligibility

If you get medical care in a country outside the U.S., FMP can only cover the cost of services medically necessary to treat these two types of conditions:

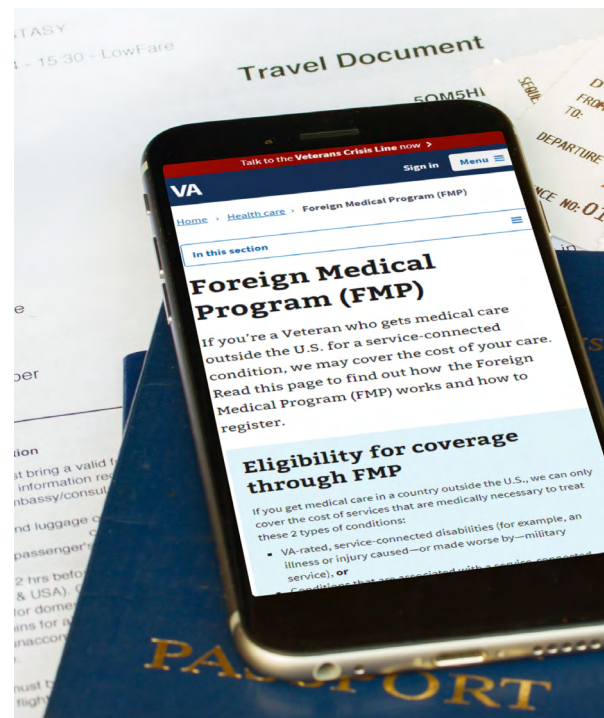
- VA-rated service-connected disabilities, or conditions associated with a service-connected disability and that aggravates your disability, or
- Veterans participating in program Chapter 31 "Veteran Readiness and Employment."

How to register with FMP

Register for FMP **online** at www.va.gov/health-care/foreign-medical-program.

OR email, mail, or fax your form (VA Form 1907959f-1) www.va.gov/find-forms/about-form-10-7959f-1.

Then you'll receive a benefits authorization letter with the service-connected condition you are covered for or the rehabilitation status for authorized treatment.



Filing a Claim

You, or the provider, can file the claim. Make sure to file a claim within two years of when you received the care.

What to submit when filing a claim:

1. FMP Claim Cover Sheet (VA Form 10-7959f-2): www.va.gov/find-forms/about-form-10-7959f-2.
2. Itemized billing statement from your provider and proof you paid the provider.
3. All medical documents for care (examples: hospital care, medical devices, equipment, or supplies, prescription medicines, or vaccines).
